

Code of Conduct

2210 Events e.V.

Last updated: 04/2026 -- Version 1.0

1. Preamble

2210 Events e.V. organises furry dance events with the goal of providing all attendees with a safe, respectful, and memorable experience. This Code of Conduct applies to all individuals participating in events organised by 2210 Events e.V., regardless of their role as a guest, volunteer, or member of the organising team.

The event management reserves the right to remove any person whose conduct violates this Code or who materially disrupts the atmosphere of the event, without providing reasons and without refunding the entry fee.

2. Scope

This Code of Conduct applies:

- for the entire duration of the event, including during entry and departure from the venue,
- throughout the entire event venue and its immediate surroundings, insofar as the conduct in question is related to the event,
- across all official digital communication channels operated by 2210 Events, including the official Telegram channel and the official account on X (formerly Twitter).

In public areas of the venue not used exclusively by 2210 Events, the house rules and regulations of the respective venue also apply. All attendees are required to comply with these.

3. Access and Admission

Access to the event is restricted exclusively to registered and fully paid attendees. The ticket or badge issued at registration serves as proof of admission. The following applies:

- The ticket or badge is non-transferable and valid only for the person to whom it was issued.
- The ticket or badge must be presented upon request to security personnel or event management at any time.
- Forging, altering, or transferring tickets is prohibited and may result in legal consequences.
- Persons without a valid ticket may be removed from the premises without further explanation.

3.1 Minimum Age

Attendance at 2210 Events is restricted to individuals who are at least 18 years of age on the date of the event. A valid government-issued photo ID must be presented at the entrance upon request. Persons who are unable to provide valid proof of age may be refused entry.

4. General Conduct

All attendees are expected to treat one another with respect and consideration. The following fundamental principle applies to all interactions at the event:

Principle: Treat others as you wish to be treated yourself. Every person deserves respect regardless of appearance, identity, background, or behaviour.

4.1 Harassment and Discrimination

Harassment, intimidation, and discrimination of any kind are strictly prohibited at 2210 Events. This includes, but is not limited to:

- physical assault, stalking, unwanted physical contact, or unwanted advances,
- verbal abuse, threats, or derogatory remarks,
- discriminatory statements or actions based on gender, gender identity, sexual orientation, origin, ethnicity, religion, nationality, age, disability, or any other personal characteristic,
- deliberate misgendering of individuals or use of names a person has rejected ("deadnaming"),
- the display or distribution of discriminatory, dehumanising, or inciting content of any kind.

4.2 Consent and Physical Contact

Any form of physical contact -- including hugging -- requires the express and unambiguous consent of the person concerned. The following applies:

- **"Yes means Yes":** Only a clear and unambiguous "yes" constitutes valid consent.
- **"No means No":** If someone asks to be left alone, this must be respected immediately and without discussion.
- **A fursuit is not consent.** Wearing a costume does not constitute implicit consent to physical contact, photography, or any other interaction.

4.3 Prohibited Symbols and Organisations

The display, wearing, or distribution of symbols, insignia, or materials of the following nature is prohibited:

- symbols and insignia of unconstitutional or banned organisations pursuant to Sections 86 and 86a of the German Criminal Code (StGB) (e.g. National Socialist symbols),
- symbols associated with the so-called "Alt-Furry" movement or comparable groups,
- materials that promote or glorify hatred, violence, or discrimination against individuals or groups.

Violations of this section will be addressed immediately and may result in removal from the event and a permanent ban from future events.

5. Attire and Costumes

2210 Events e.V. is a Safe For Work (SFW) event. All attire and costumes in public areas of the venue must meet the standards outlined below. The guiding principle is: when in doubt, cover it up.

5.1 General Requirements

- A minimum level of clothing is required in all public areas at all times: at minimum a top, shorts or a skirt, and closed footwear or fursuit paws.
- Real animal fur -- whether as part of a costume or as an accessory -- is not permitted at 2210 Events.
- Clothing, accessories, or costumes likely to offend other attendees or to bring the event or the furry community into disrepute are prohibited.
- Security personnel and event management reserve the right to assess any item of clothing or accessory on a case-by-case basis and to issue appropriate instructions.

5.2 Fursuits and Pet Suits

Fursuits and pet suits are warmly welcome. The following rules apply:

- Anatomically explicit or sexually designed suit parts (e.g. explicit genital attachments) are not permitted in public areas under any circumstances.
- Partial suits, including heads, paws, tails, or ears, are permitted without restriction provided they meet the general attire requirements above.

5.3 Harnesses and Gear

Harnesses and similar accessories are permitted under the following conditions:

- Harnesses worn over clothing are permitted.
- Harnesses worn as a standalone top, or any configuration that results in significant bare skin being exposed, are not permitted.
- Light bondage-aesthetic accessories (e.g. collars, cuffs) worn discreetly are tolerated, provided they do not form part of a full gear or fetish outfit.
- Full fetish or BDSM gear -- including outfits whose primary character is fetish-oriented rather than decorative -- is not permitted in public areas.

Note: If you are unsure whether your outfit meets these requirements, please contact the event team in advance or ask a member of the security team on-site before getting dressed.

6. Photography and Recordings

In order to protect the personal rights of all attendees, the following rules apply:

- Recordings of individuals -- whether photographic, video, or audio -- are only permitted with their express consent.

- If a person requests that no recordings be made of them, this must be respected without objection. Recordings already made must be deleted upon request.
- The publication of recordings in which individuals are recognisable without their consent is prohibited.

6.1 Official Media Coverage

2210 Events e.V. may produce official photo and video material at the event. By registering, attendees consent to recordings made of them in public event areas being used by 2210 Events e.V. for documentation and public relations purposes. No compensation is provided. Anyone who does not wish to be photographed should inform the photographer; such recordings will not be published.

Note: The official media team will be clearly identifiable as such on-site.

7. Safety and Prohibited Items

To ensure the safety of all attendees, the following items and behaviours are not permitted on the event premises:

7.1 Prohibited Items

- weapons of any kind, including replicas that could be mistaken for real weapons,
- pyrotechnic devices, fireworks, or open flames,
- illegal substances,
- glass bottles or other hazardous containers, unless expressly permitted by the venue.

7.2 Prohibited Activities

- staged fights, fire juggling, fire breathing, or similarly dangerous activities -- exceptions require the express prior approval of event management,
- the deliberate damage of property belonging to other attendees or the venue,
- entering areas not designated for attendees.

Attendees are personally liable for any damage they cause to the property of the venue, other attendees, or 2210 Events.

8. Alcohol and Substances

The minimum age for the purchase and consumption of alcohol at 2210 Events is 18 years. The following additionally applies:

- Attendees are expected to consume alcohol responsibly. Excessive consumption that impairs the wellbeing of the individual or others may result in removal from the event.
- The consumption of illegal substances is strictly prohibited throughout the event premises and will be reported to the relevant authorities.

- Persons visibly under the influence of alcohol or substances who are behaving inappropriately may be removed from the event.

9. Hygiene

In order to ensure a pleasant experience for all attendees, a reasonable standard of personal hygiene is expected. Security personnel are authorised to discreetly address any hygiene concerns with attendees. In justified cases, removal from the event may be issued.

Note: This applies in particular when wearing fursuits or form-fitting costumes over extended periods.

10. Enforcement and Consequences

This Code of Conduct is enforced by the security personnel and event management of 2210 Events. Members of the security team will be clearly identifiable as such at the event.

10.1 Reporting Violations

Violations of this Code may be reported to a member of the security team or event management at any time. All reports will be handled confidentially. No attendee should suffer any disadvantage as a result of reporting an incident.

10.2 Possible Consequences

In the event of violations of this Code of Conduct, the following measures may be taken depending on the severity of the incident:

- verbal warning,
- removal from the event without refund of the entry fee,
- permanent ban from future 2210 Events,
- referral to the relevant authorities in cases involving criminal offences.

Event management reserves the right to determine consequences at its own discretion. Decisions made by event management are final and will not be subject to further discussion during the event.

10.3 General Clause

Any conduct that significantly disrupts the operation of the event, places an unreasonable burden on other attendees, or damages the reputation of 2210 Events or the furry community may be subject to action even if not expressly referenced in this Code.

11. Medical Team

A small medical team is present on-site at all 2210 Events e.V. events. Team members are identifiable by their staff badge and are available throughout the event. The medical team is there to assist with any health-related concerns, including but not limited to:

- physical injury or sudden illness,
- heat exhaustion or overheating, particularly relevant for fursuiters,

- reactions to alcohol or other substances,
- anxiety, panic attacks, or other acute mental health concerns.

Attendees requiring medical assistance should approach any member of staff, who will contact the medical team immediately. If you are unsure who to approach, go to the entrance or bar area and ask for assistance.

The medical team operates in a strictly confidential capacity. Any information shared with the medical team in the course of receiving assistance will not be disclosed to other attendees or used for any purpose other than providing care.

Note: The medical team is a first-response resource and is not a substitute for emergency services. In the event of a serious medical emergency, the medical team will call emergency services (112) immediately.
