

Event Terms and Conditions

These Terms and Conditions apply to all attendees of Project VRMN, organised by 2210 Events n.e.V. By purchasing a ticket and/or attending the event, attendees agree to these terms in full. These Terms and Conditions are to be read in conjunction with the 2210 Events n.e.V. Code of Conduct, which forms an integral part of the contractual relationship between 2210 Events n.e.V. and each attendee.

1. Tickets and Registration

Attendance at Project VRMN requires a valid ticket purchased through the official registration system at <https://2210.events>. The following conditions apply to all tickets:

- Tickets must be presented at the entrance in digital or printed form. Entry may be refused if a valid ticket cannot be presented.
- The resale or commercial transfer of tickets is prohibited. Tickets obtained through unauthorised third parties are void.
- 2210 Events n.e.V. reserves the right to refuse entry to any person, including holders of valid tickets, where there is reasonable cause to do so (e.g. prior bans, or code of conduct violations at previous events).

2. Minimum Age

Attendance at Project VRMN is restricted to individuals who are at least 18 years of age on the date of the event. Valid government-issued photo ID must be presented at the entrance upon request. Persons unable to provide valid proof of age will be refused entry without refund.

3. Entry, Bag Policy, and Searches

The following conditions apply upon entry to and throughout the event at Kassemate 20, Hamburg:

- **Bag check:** All bags may be inspected by security personnel upon entry. Attendees who decline an inspection may be refused entry.
- **Large backpacks are not permitted.** Due to limited space at Kassemate 20, large backpacks and similar oversized bags may not be brought onto the event premises. There is no cloakroom or storage facility available for oversized items at this venue. Attendees are strongly advised to leave large bags at home or in their vehicle.
- Small bags, belt bags, handbags, and similar compact bags are permitted.
- Items prohibited under the Code of Conduct or applicable law will be confiscated at the door and may not be reclaimed.

4. Alcohol and Beverages

- **No outside alcohol.** The bringing of alcoholic beverages onto the premises of Kassemate 20 from outside is strictly prohibited. Alcohol is available exclusively at the official bar on-site.

- The purchase and consumption of alcohol is permitted for individuals aged 18 years or over only. Age verification may be carried out at the bar.
- 2210 Events n.e.V. reserves the right to refuse the sale of alcohol to any individual without providing a reason.

5. Refunds and Cancellations

The following refund policy applies to all ticket purchases for Project VRMN:

- Tickets are non-refundable once purchased, except in the event of cancellation of the event by 2210 Events n.e.V.
- In the event that 2210 Events n.e.V. cancels Project VRMN, attendees will receive a full refund of the ticket price. No further liability is accepted (e.g. for travel or accommodation costs).
- If an attendee is removed from the event due to a violation of the Code of Conduct or these Terms and Conditions, no refund will be issued.

6. Liability

Attendance at Project VRMN is at the attendee's own risk. The following applies:

- 2210 Events n.e.V. accepts no liability for loss, theft, or damage to personal property brought onto the event premises.
- 2210 Events n.e.V. accepts no liability for personal injury caused by the actions of third parties or as a result of the attendee's own conduct.
- Attendees are personally liable for any damage they cause to Kassemate 20, its fixtures, or to the property of other attendees or of 2210 Events n.e.V.
- The statutory liability of 2210 Events n.e.V. for gross negligence and intentional acts remains unaffected.

7. Photography and Media

By attending Project VRMN, attendees acknowledge that 2210 Events n.e.V. may produce official photo and video recordings in public event areas for documentation and promotional purposes.
